SUPPORTING THE ADOPTION AND ON-FARM IMPLEMENTATION OF COVER CROPPING BMPs

Through this program, the MMF will provide non-repayable funding (up to \$75,000) to Red River Métis Citizens engaged in agricultural production, to support the adoption and on-farm implementation of (1) Nitrogen Management BMP's, (2) Cover Cropping BMP's, and (3) Rotational Grazing BMP's.

Cost-share ratio:

95% non-repayable contribution
5% in-kind contribution required

Eligibility Criteria:

- Applicant must be a Red River Métis Citizen
- Applicants must currently be engaged in agricultural production on lands owned 50% or greater, by a Red River Métis Citizen(s), and must provide proof of at least 50% ownership only on the lands in which project activities will be conducted on.
- Applicants who wish to utilize project funds on rented or non-crown lease lands are required to provide the MMF with signed consent by the landowner(s), and proof of possession lasting until at least March 31, 2024. Documented proof must be provided at the time of application submission to ensure eligibility and avoid delays.
- Applicants with no alternative but to utilize project funds on crown lease lands should first contact agriculture@mmf.mb.ca to discuss eligible activities.
- Eligibility will be determined based on funding availability for applicants who's farm business holds less than 50% Red River Métis ownership of the land on which program funds will be spent.
- All project costs and activities must first be approved by the MMF before any expenses incurred by the applicant are to be eligible for payment to the applicant.
- All MMF approved project activities submitted by the applicant must demonstrate BMP that are either a new practice or an improvement to the applicants existing practices.
- Applicants must ensure all eligible activities and costs are approved and signed by the appropriate staff delivering the MMF's Manitoba Métis On-Farm Climate Action Program before any purchases or on-farm work begins.
- Applicants are welcome to include their Red River Métis values and traditions into eligible activities, provided applicant can justify how their values and traditions fit within eligible project activities.
- Costs associated with the creation of an applicant's action plan, and the labour costs to perform approved activities will be permitted with defined limits (details included within application).

Eligible Costs & Activities:

- Utilizing the services of licenced Professional Agrologists (P.Ag), with demonstrated competency, or alternatively utilize professionals with a Certified Crop Advisor (CCA) designation. Note: The MMF will utilize a Professional Agrologist for project application approval and provide sufficient virtual and on-farm supports as needed.
- Planning, Technical Assessments, and engineering or technical design fees and costs of other agronomic support
- BMPs that focus on the use of regionally appropriate cover crops in field crops and horticultural operations to protect soil from erosion, enhance soil organic matter and provide undisturbed cover over winter and early spring months,
- Fall planted cover crops as well as spring planted cover crops underseeded with the main crop (Intercropping)
- Full season annual and/or perennial cover crops in a rotation
- Costs associated with seeding and planting

Ineligible Costs & Activities:

- Planting winter cover crops that do not meet program objectives or eligibility as.

- Crops that will be harvested or grazed leaving less than 6 inches (15cm) of cover crop growth over winter
- Crops intended to be harvested in the next growing season for market (e.g. winter cereals)
- Cover crops planted to take land permanently out of production (Note: applicants may rationalise their traditional knowledge and practices to accommodate for what they define as not considered taken permanently out of production)
- Costs where the proposed practice is not a new practice (i.e., has been recently used by the applicant on the acres included in the application)
- Lift kits to convert low clearance equipment to high clearance, unless the lift kit is part of a proposed project to install equipment to support intercropping
- Costs related to mechanical or chemical termination of the cover crop (e.g., roller crimpers)
- GPS components related solely to a guidance system (e.g., autosteer systems)
- Purchase, rental, lease, or sale of land, buildings, facilities, inventory, and associated taxes and fees
- Normal operating costs associated with conducting or expanding a business
- Any cost that is eligible for a rebate, credit, or refund
- Purchase of new or used farm equipment or other assets that is deemed non-essential to implementing eligible activities as approved by the MMF.
- Purchasing livestock, feed, seed, or any costs associated beyond what is listed under eligible costs and activities (please first review all 3 factsheets)
- BMPs applied to a specific farm area prior to the Program are ineligible (Note: however, an expansion of a BMP application on a farm area where these BMPs have not recently been used are still eligible)
- Gifts and incentives
- Costs related to activities that directly influence or lobby any level of government
- Costs of training and skills development that fulfill any academic requirements
- Costs of travel, hospitality, meals, and/or accommodations
- Tile drainage systems
- Crop storage facilities (e.g., grain bins, seed storage), TMR mixers, feed pushers and automated feeding systems.
- Multi-use items that go beyond scope of project (e.g., computers, printers, hand or power tools and attachments, etc.)
- Materials or products produced by the applicant's farm business (e.g., seed)
- Invoices not issued in the applicant's name or business
- An activity can only be funded once on the same parcel of land through OFCAF funding.

In-Kind Eligible Activities:

All In-kind activities require the approval of the appropriate MMF program staff and will be determined together with applicants on or after the date of their application approval. In-kind activities must be completed by the applicant by no later than March, 2024.

- **Recommended:** Mentoring of a Red River Métis young agrarian or established producer looking to improve their knowledge (age 18-39). Note: It is possible for a mentor to also receive mentorship to gain new perspective and knowledge to improve their business.
Details on mentoring cost that can be claimed toward in-kind will be detailed during the application approval phase. (Note: Immediate family would not typically be eligible to receive mentoring).
- Maximum 3 hours at \$25 per hour can be claimed toward in-kind to complete the Environmental Farm Plan (EFP). Voluntary and confidential. The MMF will not be requesting confirmation of completion.
- Provide a gift to be distributed to Citizens in-need (e.g. Meat processed in certified facility, feed, Fur/hides, Red River Métis traditional offerings including artwork, Traditional Knowledge, bison skulls, food.
- Labour costs associated with implementing eligible activities (if they are not already claimed by the applicant)
- Other activities as determined with the successful applicant
