## ACTIVITY#1 FACT SHEET

### SUPPORTING THE ADOPTION AND ON-FARM IMPLEMENTATION OF NITROGEN MANAGEMENT BMPS

Through this program, the MMF will provide non-repayable funding (up to \$100,000, pending available funds) to Red River Métis Citizens engaged in agricultural production. This program supports the adoption and on-farm implementation of BMP's related to (1) Nitrogen Management (2) Cover Cropping or (3) Rotational Grazing.

### Cost-share ratio:

**95% non-repayable contribution**

**5% in-kind contribution required**

### Eligibility Criteria:

- Applicant must be a Red River Métis Citizen.
- Applicants must currently be engaged in agricultural production (anywhere in Canada) on lands at least 50% owned by a Red River Métis Citizen(s), and must provide proof of at least 50% ownership only of the lands where project activities will be conducted.
- Applicants who wish to utilize project funds on rented or non-Crown lease lands are required to provide the MMF with signed consent from landowner(s), and proof of possession extending at least until March 31, 2028. Documented proof must be provided at the time of application submission to ensure eligibility and prevent delays.
- Applicants who must use rented land not owned (50% or more) by a Red River Métis Citizen(s) or who must utilize Crown lease lands should first contact [agriculture@mmf.mb.ca](mailto:agriculture@mmf.mb.ca) to discuss eligible activities.
- Applications from Red River Métis businesses with less than 50% Red River Métis ownership will be considered only after those with 50% or greater ownership.
- All project costs and activities must first be approved by the MMF before any expenses incurred by the Applicant are to be eligible for payment to the Applicant.
- All MMF approved project activities submitted by the Applicant must demonstrate BMPs that are either a new practice or an improvement to the Applicant's existing practices.
- All Applicants must be able to demonstrate either a new practice or an improvement to existing practices on the land in which the activity would take place and should provide a clear benefit to the health of the land and surrounding ecosystem. Applicants who have previously received program funds must propose projects that adopt or implement new BMPs, or expand previously adopted BMPs onto new hectares.
- Applicants may incorporate Red River Métis values and traditions into eligible activities if they can justify how these align with the project's objectives.
- Costs associated with the creation of an Applicant's action plan, and the labour costs to perform approved activities will be permitted with defined limits (details included within application).

### Eligible Costs & Activities:

- Utilizing the services of licensed Professional Agrologists (P.Ag), with demonstrated competency, or alternatively include professionals with a Certified Crop Advisor (CCA) designation. **Note: The MMF will utilize a Professional Agrologist for project application approval and provide sufficient virtual and on-farm supports as needed.**
- Costs associated to transitioning to or improving existing manure management. **Note: Injection is preferred; however, if equipment for this is not available, other methods of incorporation as soon as possible after application are also eligible. Solid manure should be incorporated as soon as possible to avoid ammonia loss.**
- Use of polymer coated urea (PCU).

- Nitrification and urease inhibitors (must be used together and not in combination with PCU).
- Split application of fertilizer with reduced rate as a result of increased crop use efficiency.
- Costs for using equipment and the associated fuel and labour required for an additional fertilizer application. **Note: Determination of costs for using equipment and the associated fuel and labour required for the additional fertilizer application needs to be in line with local custom rates.**
- Cost of fertilizer application equipment and equipment upgrades to allow for banding, side dressing and injection **Note: All equipment purchases or upgrades will be limited to no more than \$30,000 per Applicant for the lifetime of the program. Applicants who are approved for the purchase of equipment must also report on related BMP implementation that is possible through the use of the equipment.**
- If transitioning to manure, costs associated with spreading, using hoses or equipment for shallow incorporation (to avoid volatilization).
- Planning, technical assessments, and engineering or technical design fees and costs of other agronomic support (e.g., nutrient management plan, crop diversification plan).
- Soil testing and soil mapping costs. **Note: Soil testing and mapping expenditures (combined) will be limited to no more than \$25,000 per Applicant for the lifetime of the program.**
- Use of soil organic amendments and synthetic fertilizer substitutes (manure/solid manure, compost, digestates).
- Seed and planting costs associated with increasing legumes in rotations.
- Costs associated with application of nitrogen in spring instead of fall.

## Ineligible Costs & Activities:

- Purchase, rental, lease, or sale of land, buildings, facilities, inventory, and associated taxes and fees.
- Normal operating costs associated with conducting or expanding a business.
- Materials or services purchased outside the eligible invoice dates.
- Any cost that is eligible for a rebate, credit, or refund.
- Purchase of new or used farm equipment or other assets that are deemed non-essential to implementing eligible activities as approved by the MMF (e.g., tractors, skid steers, combines, grain car).
- Purchasing livestock, feed, seed, or any costs associated beyond what is listed under eligible costs and activities (please first review all 3 factsheets).
- Use of biosolids.
- Costs related to the management of nutrients other than nitrogen are not eligible.
- BMPs applied to a specific farm area prior to the program are ineligible; however, an expansion of a BMP application on a farm area where these BMPs have not recently been used are still eligible.
- Gifts and incentives.
- Costs related to activities that directly influence or lobby any level of government.
- Costs of training and skills development that fulfill any academic requirements.
- Costs of travel, hospitality, meals, and/or accommodations.
- Tile drainage systems.
- Crop storage facilities (e.g., grain bins, seed storage), TMR mixers, feed pushers and automated feeding systems.

- Multi-use items that go beyond the scope of the project (e.g., computers, printers, hand or power tools and attachments, etc.).
- Materials or products produced by the Applicant's farm business (e.g., seed).
- Invoices not issued in the Applicant's name or business.

## In-Kind Eligible Activities:

All in-kind activities require the approval of the appropriate MMF program staff and will be determined together with Applicants on or after the date of their application approval. In-kind activities must be completed by the Applicant by no later than March 31, 2026.

- **Recommended:** Mentoring of a Red River Métis young agrarian or established producer looking to improve their knowledge (age 18-39). *Note: A mentor may to also receive mentorship to gain new perspective and knowledge to improve their business. Details on mentoring costs that can be claimed toward in-kind will be detailed during the application approval phase. Note: Immediate family members are typically not eligible to receive mentoring.*
- Labour or equipment hours associated with implementing eligible activities (if they are not already claimed by the Applicant).
- Maximum 3 hours at \$25 per hour can be claimed toward in-kind to complete the Environmental Farm Plan (EFP). This process remains voluntary and confidential; the MMF will not request confirmation of completion.
- Provide a gift to be distributed to Citizens in-need (e.g. meat processed in certified facility, feed, fur/hides, Red River Métis traditional offerings including artwork, Traditional Knowledge, bison skulls, food).
- Other activities as determined on a case-by-case basis with each successful Applicant.
